1. Introduction

1.1. About us

In this Privacy Notice references to "we" or "us" or "our" are to:

NWUPC Ltd (**NWUPC**), a company registered in England and Wales (company number 4045190) with registered address at NWUPC Ltd, Room 404, 4th Floor, Crescent House, University of Salford, Salford, M5 4WT.

We act as data controller in respect of the personal information that we process.

1.2. About this Privacy Notice

This Privacy Notice tells you what personal information we collect, and why we need it, how we use it and what protections are in place to keep your personal information secure.

The type of personal information we collect about you – and the personal information we obtain from third parties - depends to some extent on your circumstances, your role with a member or a supplier (if applicable) and our legal obligations.

This Privacy Notice was last updated on 21 February 2020.

Any changes to this Privacy Notice will be highlighted to you in an updated Privacy Notice.

1.3. What is 'personal information'?

Your 'personal information' means information about you, and any information from which you can be identified - either by reference to an identifier (for example your name, location data or online identifier (IP address)) or from factors specific to your physical, cultural or social identity.

2. Who do we collect personal information from?

We may collect personal information:

- From you, where you visit our Website, complete one of our online forms or contact us;
- From NWUPC members; and
- From suppliers appointed to Framework Agreements available to NWUPC members.

3. How do we collect personal information?

3.1. Information provided to us by you

Personal information is provided to us by you:

- when you enter information into our Website or online forms; and
- when you contact us by email, by telephone or by post.

3.2. Information collected automatically by us

Personal information is collected by us automatically, when you visit our Website.

3.3. Information provided to us by third parties

Personal information is provided to us by third parties such as NWUPC members and suppliers:

- by email;
- hard copy document;

- by telephone; and
- in person.

4. What personal information do we collect and process?

4.1. Information provided to us by you

Personal information provided to us by you may include, as applicable:

- information that you give us by entering information into our Website and online forms, e.g. your name and contact details given; and
- information that you give us when corresponding with us by email, by telephone, or by post, e.g. your name and contact details.

4.2. Information collected automatically by us

Personal information collected by us automatically, when you visit our Website, may include:

- technical information, including [the Internet protocol (IP) address used to connect your computer to the Internet, your login information, browser type and version, time zone setting, browser plug-in types and versions and operating system and platform]; and
- information about your visit, including [the full Uniform Resource Locators (URL), clickstream to, through and from our site (including date and time), what you viewed or searched for, page response times, download errors, length of visits to certain pages, page interaction information (such as scrolling, clicks, and mouse-overs) and methods used to browse away from the page.

4.3. Information provided to us by third parties

Personal information provided to us by third parties such as NWUPC members and suppliers may include:

- your name and contact details;
- your employment details; and
- your CV.

5. What do we use your personal information for?

5.1. Information you give to us

We will use this information:

- to provide you with any information or assistance requested by you.
- to send you marketing emails regarding NWUPC events, training and other membership benefits. With your permission, we may pass your details on to framework suppliers so that they may contact you about their products and services.

In these circumstances, the legal basis for processing the data is your consent.

Please note that you have the right to withdraw your consent to this processing at any time by contacting us using the details set out in the Introduction section above. If you choose to withdraw your consent, this will not affect the lawfulness of the processing that occurred prior to the withdrawal.

5.2. Information collected automatically by us

We will use this information:

- to administer our Website and for internal operations, including troubleshooting, data analysis, testing, research, statistical and survey purposes;
- to improve our Website to ensure that content is presented in the most effective manner for you and for your computer;
- to allow you to participate in interactive features of our Website, when you choose to do so; and
- as part of our efforts to keep our Website safe and secure.

In these circumstances, the legal basis for processing the data is our legitimate interest in administering and improving our Website and its features, and keeping our Website secure.

5.3. Information provided to us by third parties

We will use this information:

- for the purposes of administration in relation to NWUPC members (please see a list of our members [here](#)); and
- for the purposes of contracts entered into between NWUPC members and suppliers.

In these circumstances, the legal basis for processing the data may be the legitimate interest of NWUPC, its members and third party suppliers to conduct business operations.

6. Who do we share your personal information with?

We may share your personal information with the following third parties, where relevant:

- our members – to enable members to contact each other and facilitate collaboration;
- our suppliers;
- our staff, agents and contractors – to enable us to deliver the core business of procurement frameworks;
- our professional advisors;
- third party contractors that provide services to us (such as HE Contracts, In-Tend, Hunter Database, The University of Manchester, University of Liverpool and Bristol Online Surveys (**BOS**)); and
- analytics and search engine providers that assist us in the improvement and optimisation of our site.

We may also share your information with third parties such as regulatory authorities, or where we are under a legal obligation to disclose your information (for example where we are required to share information in accordance with legislation, to prevent fraud and other criminal offences, or because of a

court order). We may disclose your information in order to enforce our legal rights or to protect the legal rights of our members or others.

7. How do we keep your personal information safe?

7.1. What we do

We have security measures in place to restrict access to personal information, to guard against unauthorised or unlawful processing of personal information and against damage to, accidental loss or destruction of, your personal information.

The security measures applied include:

- hard copy records and manual files are kept to a minimum but those kept are in locked filing cabinets and
- electronic records are kept in an electronic filing system with access restricted to NWUPC staff

7.2. Third parties

8. How long do we keep your personal information for?

We keep your personal information only for as long as is reasonably necessary for the purposes for which we process your personal information. These purposes are listed at section 5 of this Privacy Notice **What do we use your personal information for?**

Your personal information is kept for as long as your institution remains a member of NWUPC. In the case of suppliers, bidder information will be held in line with the requirements of the Public Procurement Regulations, whilst marketing contacts will be deleted at the end of the contract term.

9. Automated decision making and profiling

No automated decision making or profiling is carried out by NWUPC.

10. International data transfers

We do not transfer your personal data outside of the EEA. Where our third party contractors process your personal data outside of the EEA they are required to ensure the adequate protection of your personal data.

11. Your rights
