The new Procurement Bill: Transforming public procurement

The new <u>Procurement Bill</u> is currently passing through Parliament, having had its first reading in the House of Lords on the 11th May 2022. This follows the Queen's Speech on the 10th May 2020 which stated that public sector procurement will be simplified to provide new opportunities for small businesses.

The Bill is intended to:

- Create a simpler regime that works better for the UK, reducing costs and improving productivity.
- Establish a single digital platform for supplier registration, businesses will only have to submit their data once to qualify for any public sector procurement.
- Give public sector buyers more freedom and flexibility by allowing them to better negotiate with suppliers and to design the buying process to meet the needs of their specific procurement.
- Enable smaller contracts to be restricted to UK suppliers, as permitted by World Trade Organization rules, and ensuring that procurement activities aid jobs and innovation.

Procurement Bill [HL]

Government Bill

Originated in the House of Lords, Session 2022-23



The Bill will take several months to complete its passage through Parliament. The Government will give a minimum of six months' notice before 'go-live'; this will not be until 2023 at the earliest. The existing legislation will apply until the new regime goes live and will also continue to apply to procurements started under the old rules. Guidance will be provided to cover the transition from the old to the new regulations.

2020/21 UKUPC Impact Statement

NWUPC are pleased to bring you the 2020/21 UKUPC (UK Universities Purchasing Consortium) Impact Statement, highlighting how institutions like yours have benefited through consortia collaboration.

UKUPC is a partnership between eight UK purchasing consortia created to support collaborative procurement within Higher and Further Education. Through collaborative working, UKUPC partners reduce duplication across the UK, build resilience and deliver measurable value to members. You are receiving this report because NWUPC actively contributes to this partnership and we think it's important that you know how that is benefitting your institution.

Here are a few highlights, but please do read more within the report:

- Members spent £1.3BN through consortia frameworks and achieved £76M in cashable savings and £104M in non-cashable/process savings. (Savings are calculated using the HEPA Benefits Methodology)
- Members had access to over 100 agreements covering a wide range of strategic spend areas for your institution.
- Members accessed risk assessments and best practice guides, along with guidance and support to address significant challenges such as thriving in a new normal, managing major disruptions to the supply chain and supporting sustainability.
- Members can access 180 SMEs through UKUPC frameworks SMEs make up just over 60% of our awarded suppliers across all frameworks.

We have an extremely challenging programme coming up and we are looking at the most effective ways to deliver the agreements that are needed now, in ways that offer flexibility and ease of use.

We've also been dealing with an unprecedented number of requests for commercial review particularly within the Domestics and Office Solutions Categories with the supply chains being hit by several large macro environmental events. We have a detailed process to ensure that all requests are treated reasonably and both suppliers and members are treated fairly but with value at the centre of any approvals. Cost increases put forward by Banner, OT Group, Lyreco and Premier Paper are currently under consideration, The turmoil in the paper market is still on-going albeit the Easter holiday was a slower sales period for all of the suppliers which has resulted in stock levels and availability increasing slightly. The Scandinavian mills affected by the strike at UPM is finally over after 117 days although it will be a number of weeks before stock is produced and released to distributors.
